
The monopole will have a galvanised steel finish – so grey in colour.

The cabinets will be an Ivy Green colour (BS 4800 12 C 39) with dimensions of 1500x1800x707 and the smaller cabinet 1130x550x255.

There will be minimal disruption to vegetation during Build: a crane and a team at ground level will direct the crane where trees will be fenced off to prevent harm to canopies.

Removal of limited quantity of the shrubbery with possible compensatory re-planting – subject to site provider agreement.

The cabinet and pole foundations are to be hand – not machine – dug, to minimise damage to roots of trees [A, B and C].



Excavations for the pole root and cabinet limited to square area of pole and cabinet foundations with cabinet foundation a mere 300mm in depth.

As standard practice when installing such apparatus, earth will be removed by hand. Any roots found during this excavation will be severed using a sharp handsaw or secateurs. This will ensure that the roots are not ripped or torn, and will have a good point from which to regrow, and will have a chance to occlude and prevent fungal pathogens from entering. Any root removal will be so minor as not to affect the overall root system of any of the adjacent trees.
