ASBESTOS WASTE TRANSFER STATION

It is the intention of the directors should they be successful in obtaining the necessary Permit from both the South Tyneside Council and the Environment Agency to set aside a small area of the existing location of the company in which to carry out the activity.

It must be made clear from the outset that the directors have no intention of carrying out any form of processing on any of the waste which will be transported to our site for disposal.

The directors seek to operate a simple facility consisting of up to four(4) suitable fully enclosed and lockable, RoRo or smaller 12cu yd skips or a mixture thereof.

As well as enabling PASL to deal legitimately with our own asbestos waste, it will allow us to accept Asbestos waste from other contractors and the general public.

All waste accepted at the site will either be double bagged or wrapped in polythene as is the present requirement imposed on all asbestos removal companies under current Asbestos legislation. As for asbestos waste accepted from the general public this too will be double bagged or wrapped and will be transported to the waste transfer station by ourselves. Under no circumstance will the directors accept waste brought to the waste station which still required bagging or wrapping. Neither do they expect fly tipping to be a problem as the area is patrolled by a night watchman.

The site of the proposed station is quite isolated with only one road for both entry to and exit from our proposed site.

Management of the day to day activities of the facility will be carried out jointly by Janice Kennedy one of the company directors and Kevin Cobb – formally of Alex Smiles Ltd of Sunderland, who operated the hazardous waste side of their operation until recently. Kevin possesses the WAMITAB qualification certificate attached, valid till 2016.

As there will be no plant used or any attempt to treat the waste in any way shape or form, there can be no aqueous waste, nor will there be any use of energy, excessive noise, emissions, odours, or the need for abatement systems as a breach of the bags / wraps either minor or major is highly unlikely, however as we will be dealing with asbestos the company will ensure that equipment and materials are on hand to control any leakage.

The operatives undertaking the transfer of the waste to the skips will be suitably trained and experienced asbestos operatives.

Kevin Cobb has also just completed his asbestos operatives course so as to familiarise himself with how to deal with such a situation.

All operations on site will occur during normal working hours except for emergency callouts.

The only remaining significant issue to be considered is that of water contamination. To resolve this issue the company proposes to erect a temporary structure over the proposed waste transfer site from scaffolding and cover it with corrugated sheeting to minimise the amount of water in the area.

The site has already been concreted to facilitate the construction of a three sided storage area any runoff of water coming from the roof will not be contaminated in any way.
