

## **Desk Study Report**

### 1 INTRODUCTION AND SCOPE OF WORKS

- 1.1 Solmek were instructed by Paul Pattinson of Hebburn Properties Ltd to undertake a desk study on land at Waterside Park, Hebburn, Newcastle-Upon-Tyne.
- 1.2 The following steps may be required in the investigation and remediation of potentially contaminated land:
  - Phase 1: Desk Study
  - Phase 2: Intrusive Investigation
  - Phase 3: Remediation Statement
  - Phase 4: Validation Reports
- 1.3 Phases 1 and 2 are generally required in the redevelopment of most sites. Phases 3 and 4 are subject to the findings of the initial stages. This report represents Phase 1 of the site investigation.
- 1.4 The purpose of this desk study is to evaluate the ground conditions of the site based on existing information and to plan the scope of the subsequent investigation. The objectives and planned outcomes of the desk study are:
  - to assess the impact of local authority guidance on the investigation
  - to identify existing features on and near the site
  - to evaluate the historical and environmental setting of the site
  - to assess the likelihood of finding contamination, its nature and extent
  - to identify associated key contaminants
  - to identify sensitive receptors and define source pathway receptor relationships (conceptual model)
  - to identify relevant geotechnical parameters
  - to refine the design and scope of the proposed intrusive investigation (if necessary)
  - to identify constraints to the investigation, i.e. site access and health and safety considerations
- 1.5 This assessment has been undertaken with due regard to contaminated land guidance, issued by the Royal Institution of Chartered Surveyors (RICS) and BS 10175: 2001, "Code of *Practice for the Investigation of Potentially Contaminated Land*". Selected elements of BS 5930: 1999, "Code of Practice for Site Investigations" has also been included.

## 2 REGULATORY AND PLANNING CONTEXT

- 2.1 The Town and Country Planning Regime is the principal means by which contamination is dealt with by the Local Authority. Contaminated land is a material planning consideration and contamination assessments are required on land that may be potentially contaminated.
- 2.2 The Buildings Regulations (2000) also state that "precautions shall be taken to avoid danger to health and safety caused by substances found on or in the ground covered by the building". A site investigation is frequently required to satisfy the requirements of building control.

## **3 SITE DESCRIPTION**

- 3.1 The preliminary site inspection, as recommended in BS5930 and BS10175, was undertaken on 29<sup>th</sup> March 2006. A site location map is presented in Figure 1, Appendix 1. The site is centred at Ordnance Survey Co-ordinates 430340E, 564570N.
- 3.2 The site is located to the north west of Hebburn, South Tyneside and currently comprises an area of undeveloped land to the south of a new housing estate (Waterside Park). The site covers an area of approximately 0.2ha.
- 3.3 The entrance to the site is accessed from the main road into the housing estate. The entrance is generally flat and leads to one side of, and behind an existing bungalow where the site opens out to reveal a moderate slope trending to the north west. There are a number of plateaus along the south eastern third of the site and the slope gradient increases further to the east beyond this. The ground surface is covered in scrub grass vegetation including thorn bushes. A number of areas in the north and east are boggy and moss has grown within the grass. A channel (running south east to north west) had been excavated down the slope near the northern boundary and this was gently issuing water indicating a possible spring further up the slope. Trees are located at the top of the slope to the east and along the bottom of the slope to the west.
- 3.4 The site is bound to the north by the rear gardens of the housing estate. Trees mark the western boundary along with a broken concrete post and wire fence. The ground slopes down to the west to an open grassed area including a playing field and a series of footpaths. A footpath circles the southern boundary beyond some trees and continues along the eastern boundary. A large factory or works is located to the east and part of the building consists of three tall chimneys.
- 3.5 No significant sources of contamination were observed during the site walkover. Some general litter was located around the periphery of the site.

## 4 SITE HISTORY

- 4.1 In order to determine the history of the site, previous editions of Historical Maps and Ordnance Survey Plans were inspected. Selected map extracts are presented in Appendix 2.
- 4.2 Table 1 presents a summary of the history of the site from 1862 to 2000. The summary focuses on the historical land uses and changes relevant to the site and the proposed end use.

4.3 In brief, the site has been directly associated with heavy industrial activity in the past. Industry on the site included an alkali works (up to 1941) with railway lines; industry in close vicinity included a rifle range, colour works, electrical engineering works, bauxite works, further railway lines and tanks. The site was also shown to contain an earth embankment. The site lies in an area of mixed land use. Due to the lack of definition of some of the map extracts however, not all previous land uses may have been identified.

### 5 ENVIRONMENTAL CONTEXT

5.1 The services of Envirocheck were used to establish the pertinent environmental records relating to the site. This information, which is presented in Appendix 3, replaces much of the information traditionally provided by the Environment Agency. Selected relevant information is summarised as follows. Measurements are taken from the centre of the site and all distances quoted are approximate.

#### Landfill and Waste

5.2 Records of landfill, waste transfer, treatment and disposal facilities have been examined. Records indicate that there are two landfill sites, eight waste management facilities, four waste transfer sites and four waste treatment or disposal sites located within 1km of the site. The nearest site is a British Geological Survey landfill 294m south west; however no information is available as to the type and age of waste. The other landfill site is located 593m south west and was authorised to receive clean inert hardcore/building rubble; the licence for the site is known to have been surrendered in 1994.

#### **Regulated Industries**

- 5.3 There are no industrial activities registered under the IPC (Integrated Pollution Controls), Explosive Sites, Notification of Installations Handling Hazardous Substances (NIHHS), Planning Hazardous Substance Consent, Regulations or the Control of Major Accident Hazards (COMAH) Regulations within 1km of the site.
- 5.4 There is one industrial activity registered under the IPPC (Integrated Pollution Prevention and Control) Regulations and two sites are subject to Radioactive Substance Consents within 1km of the site centre. The nearest site refers to Blackett Charlton Metal Testing 697m west for use of radioactive sources; however the licence has been revoked or cancelled.

Air

5.5 There are four sites subject to local air pollution controls within 1km of the site. The only current valid licence is held for a petrol filling station 676m south east along Victoria Road West.

#### Industrial Land Use

5.6 The Envirocheck Report identifies current industrial land use named as contemporary trade directory entries. There are no current industrial land uses within 250m of the site. See Envirocheck report (Appendix 3) for full details.

#### Environmentally Sensitive Areas

5.7 There are no Sites of Special Scientific Interest (SSSI), Special Protection Areas, Ramsar Sites, Environmentally Sensitive Areas, National Parks or National Nature Reserves located within 1km of the site.

### 6 GEOLOGY, GROUNDWATER & SURFACE WATER

#### Geology

6.1 Inspection of the published geological data (Sheet 21, Sunderland) indicates that the site lies on made ground over drift deposits of Upper or Pelaw Clay. The solid geology comprises Westphalian C Middle Coal Measures of the Carboniferous Age. The Bottom and Top Hebburn Fell coal seams are shown to sub crop just to the east of the site.

6.2 Two geological faults are shown in close vicinity to the north and south of the site, with the sites shown to lie on the downthrown side of both faults.

#### Geological Hazards

6.3 The Envirocheck report states that no hazard is posed by ground dissolution and collapsible ground subsidence on site. A moderate hazard exists for compressible ground. There is a very low risk of running sand, shrinking/swelling clay and landslide subsidence. For full details see the Envirocheck report (Appendix 3).

#### Radon Risk

6.4 The site falls within a 5km square area in which less than 1% of homes are above the radon action level and no radon protective measures are required in rew homes. However, consultation with the local council regarding radon specific protection measures is recommended.

#### Mining Situation

6.5 The Envirocheck report states that the site is in an area affected by coal mining. As a result, a mining report was requested on 28<sup>th</sup> March 2006. The mining report, dated 10<sup>th</sup> April 2006, indicates that there are three worked seams at depths ranging from 292 to 327mbgl. The shallowest seam is the High Main and has a section of 180cm. There are no opencast workings, tips, lagoons, shafts or adits in the vicinity of site. No further workings are likely. The report is presented in Appendix 4.

### Ground and Surface Water

- 6.6 The underlying solid geology beneath the site is a minor aquifer with soils of a high leaching potential. Minor aquifers are formations of fractured or potentially fractured rocks, which do not have a high primary permeability, or other formations of variable permeability including unconsolidated deposits. Although not producing large quantities of water for abstraction, they are important for local supplies and in supplying base flow to rivers.
- 6.7 The site is not situated within a Source Protection Zone for a protected water source as designated by the Environment Agency.
- 6.8 The nearest surface water feature is the River Tyne, which lies approximately 300m to the west of the site centre.
- 6.9 There are no records of abstraction licences within 1km of the site. There are seventy-three discharge consents within 1km of the site, generally relating to industrial, storm sewage overflow and sewage discharges into the River Tyne. The nearest current licence is located 308m west of the site and licenced to Northumbrian Water Ltd for sewage discharge due to storm overflow into Tyne Estuary.
- 6.10 The site does not lie in an area previously affected by flooding or extreme flooding from any type of water source.
- 6.11 There have been five pollution incidents to controlled waters, the nearest of which took place 185m north west on 5<sup>th</sup> Nov 1993. The pollutant was unknown, released into a saline estuary and was categorised as a minor incident.

#### Information Supplied by the Client

6.12 A site investigation report prepared by Harrison and Company was issued by the client (dated August 1994). It refers to the former Nestle Factory and the surrounding area which

ENVIRONMENTAL & GEOTECHNICAL ENGINEERS includes the area with which this desk study is concerned. The investigation included ten boreholes and ten trial pits across the Nestle Factory site. Two of the trial pits were excavated within the area of interest (TP's 8 and 9). Chemical analysis was undertaken on thirty-two soil samples and one water sample and the results were compared to ICRCL guidelines. A decontamination strategy was devised for the site which was divided into four zones (A to D). TP8 fell into Zone A and TP9 is shown in Zone C. In Zone A it was recommended that excavation and removal of all materials should be undertaken between existing ground level and a maximum depth of 0.7m. In Zone C it was recommended that ground where buildings or hardstanding were proposed did not require remediation. However where soft landscape/gardens were proposed it was recommended that 0.2m of clean topsoil should be imported.

- 6.13 In a letter to Tyne and Wear Development Corporation from Mario Minchella Architects (dated 16/11/95) it was stated that in Zone A 0.8m will be removed and used under landscaped areas with a capping system of 0.5m good clay and 0.6m subsoil/topsoil over these areas. A series of further organic testing together with gas monitoring was also proposed. A landfill gas monitoring report was also supplied by the client. Six monitoring wells were located within the area with which this desk study is concerned (No's 1 to 5 and 18). Three monitoring visits were undertaken during Nov/Dec 1995. No methane was detected, the maximum reading of carbon dioxide was 1.7% (Location 4) and oxygen levels did not fall below 18.3% volume within these monitoring points.
- 6.14 Results from Toluene Extract and Total Hydrocarbons were supplied in a letter dated 4/12/95. Samples 5 and 6 appear to have been taken from the area with which this desk study is concerned. The maximum concentration of toluene was 3320mg/kg and total PAH was 1620mg/kg, both from sample 5. The report states that "these amounts are not excessive and should not cause any problems when building."

## 7 PRELIMINARY GEOTECHNICAL ASSESSMENT

### Relict Foundations and Made Ground

7.1 The site currently lies unoccupied. From the evidence gathered for this report, it would appear that the site has seen development over the period of time covered by the historical map extracts. Therefore, there is the possibility of relict foundations from previous land uses, and from the presence of former railway lines. The published geological data and historical map extracts highlight the site lies on an area of made ground. Therefore, there is a high possibility of encountering deeper deposits of made ground. However a phase two intrusive investigation would uncover the exact type and extent of deposits present.

#### Excavations and Groundwater

- 7.2 The published geological records indicate that the site will be underlain by made ground on to drift deposits of clay. It is therefore, considered likely that excavations above rock head should be easily achievable by means of a normal excavator.
- 7.3 Due to the close proximity of the River Tyne, and the presence of a drainage channel through the site running south east to north west groundwater is likely to be encountered in deeper excavations. Care should be taken in excavations close to the river due to the possibility of ground subsidence. A perched water table may be present and groundwater levels vary with season and rainfall.

#### Mining

7.4 The site is in an area affected by coal mining. The shallowest seam is the High Main at 292m deep and has a section of 180cm. It would appear that the known worked coal seams are at a significant depth as not to pose a risk to the site development.

### 8 PRELIMINARY CONTAMINATION ASSESSMENT

- 8.1 The desk study has revealed that the site has been potentially exposed to contamination, with construction and demolition waste, asbestos and organic/inorganic compounds from the former alkali works the most likely source of potential pollution. Raised levels of ash could also be present due to the former railway lines which passed through the site.
- 8.2 The proposed development of the site is for residential housing, with access roads and driveways forming areas of hardstanding and gardens as soft landscaping. This type of land use is considered to be highly sensitive to contamination given the end users are likely to include adult and infant receptors.

8.3 As a specific source of contamination has been identified, it is recommended that a general screen of contaminants should be tested for along with asbestos and organic compounds such as total petroleum hydrocarbons (TPH) and polycyclic aromatic hydrocarbons (PAH) during a site investigation, based on guidance in CLR Report 8 "Potential Contaminants for the assessment of Land". This includes:

- a range of metals produced by a variety of industrial processes, and typically found in made ground
- acidity/alkalinity acid or alkaline wastes are produced by quarries as well as other industries
- asbestos frequently found in demolition rubble
- arsenic and sulphates elevated levels typically found in ash
- organic compounds common industrial contaminants

## 9 PHASE TWO – INTRUSIVE INVESTIGATION WORK

- 9.1 Based on the information collated in this desk study a phase two intrusive investigation is recommended. The investigation should comprise a day of borehole drilling (typically 5-6 per day) around the site to establish shallow ground conditions and provide information on the bearing capacity of the underlying ground. Boreholes should be drilled to 5m below ground level or to rockhead which ever is shallower. If poor ground conditions are encountered then boreholes may need to be extended. CBR's should be undertaken in the proposed road and driveway areas to provide information on the capping required for areas of hardstanding.
- 9.2 Ground gas and water monitoring pipes should be installed in two boreholes to assess the shallow ground gas and water levels beneath the site.
- 9.3 Selected samples of soils should be submitted for contamination and geotechnical testing. Testing requirements may vary depending on the thickness of made ground encountered, the nature of the natural soils and the depth to rock head.
- 9.4 Site investigations are designed according to the type of development, the requirements of the client, and recommendations in BS 5930 and BS 10175.

## 10 PRELIMINARY CONCEPTUAL MODEL AND RISK ASSESSMENT

10.1 The conceptual model (Table 2) collates the salient aspects of the site to form a model which should enable comparison after fieldwork and testing. This model identifies the potential pollution linkages that may influence the proposed development and geotechnical considerations. The risk ratings are based on the current potential liabilities and likely potential future liabilities. This should not be used as to a guide of the cost of addressing site specific ground issues. The risks posed by the geotechnical and contamination aspects of the site will be revised following site works, and any mitigating action required added.

## 11 CONCLUSIONS & RECOMMENDATIONS

11.1 The results of the desk study are presented in this report and Solmek can comment as follows:

Existing Features on and Near the Site

11.2 The site is located to the north west of Hebburn, South Tyneside and currently comprises an area of undeveloped land to the south of a new housing estate (Waterside Park). A large factory or works is located to the east of the site and part of the building consists of three tall chimneys. Site lies in an area of mixed land use of residential and industrial.

## Historical and Environmental Setting

- 11.3 In brief, the site has been directly associated with heavy industrial activity in the past. Industry on the site included an alkali works with railway lines; industry in close vicinity included a rifle range, colour works, electrical engineering works, bauxite works, further railway lines and tanks. Not all previous land uses may have been identified.
- 11.4 The site is likely to be underlain by made ground over drift deposits of Upper and Pelaw Clay. The solid geology is expected to comprise Middle Coal Measures. The solid geology is designated a minor aquifer.

#### Impact of Local Authority Guidance

11.5 The site could be considered contaminated with regards to Part IIA of the Environmental Protection Act and the local authorities contaminated land strategy, the contamination status of the site will be considered as part of the planning process to ensure the site is suitable for use.

### Likelihood of Finding Contamination, its Nature and Extent and Key Contaminants

11.6 Based on the desk study searches, information supplied by the client and site walkover, there is the possibility of raised levels of contamination from the former alkali works and railways on site, along with further heavy industry which has been located within 250m of the site. If elevated levels are encountered then a phase three remediation statement will be required. Possible asbestos fibres, raised levels of heavy metals and raised levels of organic compounds could be encountered.

#### Source – Pathway – Receptor Relationships

11.7 Pathways (as detailed in the conceptual model) may exist between the potential contamination in the made ground and human health, vegetation, construction materials and water. The site investigation will provide information to assess these pathways and the risks posed.

#### Geotechnical Considerations

11.8 The proposed development comprises the development of residential housing, with access roads and driveways forming areas of hardstanding and gardens as soft landscaping. It would be prudent therefore to carry out a site investigation to determine the underlying ground conditions as it is likely that the bearing pressures of the new development will differ from the original land use, and to determine the depth and extent of made ground.

#### Intrusive Investigation

- 11.9 Based on the information collated in this desk study a phase two intrusive investigation is recommended. The investigation should comprise a day of borehole drilling (typically 5-6 per day) around the site to establish shallow ground conditions and provide information on the bearing capacity of the underlying ground. Boreholes should be drilled to 5m below ground level or to rockhead which ever is shallower. If poor ground conditions are encountered then boreholes may need to be extended. CBR's should be undertaken in the proposed road and driveway areas to provide information on the capping required for areas of hardstanding.
- 11.10 Ground gas and water monitoring pipes should be installed in two boreholes to assess the shallow ground gas and water levels beneath the site.


#### Mining


