REMOVAL OF TWO DEFECTIVE HEADS AND 1 CILL USING TEMPLATES TO REPLACE WITH A LOCAL NORTHUMBRIAN BUFF SANDSTONE TYPICALLY USED IN THIS AREA. THE CILLS AND HEADS WILL BE TOOLED TO MATCH THE EXISTING STONEMASONRY, THE SHAPE AND SIZE OF HEADS AND CILLS WILL BE COPIED EXACTLY.
