Change of use from C1 to C3 for a Children's home. The home will be for children aged 8-17, with autism, learning disabilities and sensory impairment. There will be a net loss of bed and breakfast rooms/accommodation, but a net gain in residential institution accommodation/rooms.

The properties currently have 16 bedrooms between the two properties, we will be using 6 of these as bedrooms and creating learning space, sensory experience and storage solutions in the remaining rooms.

123 is currently used as a B&B, 125 is being used as a residential property. We are looking to change the use of both 123 and 125 to use both properties as a children's home as described above.

There will be no changes to the layout of the properties and no additional parking needed as the staff who will be working in this home work on a rota basis.
