Installation of an all weather two lane cricket training net on unused brown field land within the boundary of Boldon CA Sports Club. The land was fenced off many years ago. The substrate is building rubble from the demolition of colliery buildings that stood here in the past. Change of use would be from unused urban land to high quality sports facility. The new facility consists of a level playing surface 33m long and 7.3m wide which supports an open steel frame carrying nylon nets standing 4m tall. The facility will be surrounded by a gated galvanised steel fence standing 2m tall. The gates will open onto the existing cricket field. Structure is described in document: 1 Two Lane Enclosed Sec Fence
