Details of the pre-application advice received

South Tyneside Council, acting as Local Planning Authority, has considered whether a proposed 2.59-hectare Battery Energy Storage System (BESS) on the vacant former M H Southern timber yard at Church Bank, Jarrow, requires an Environmental Impact Assessment. The scheme is classed as Schedule 2 development under the 2017 EIA Regulations because it is an industrial installation for electricity production exceeding 0.5 ha, but the site is not in a sensitive area. The authority therefore undertook a screening exercise against Schedule 3 criteria and found no likely significant environmental effects.

The BESS, to be built on concrete foundations lower than the present redundant buildings, would reuse the existing access from Church Bank and maintain security fencing, CCTV and lighting. Although demolition could expose land contamination, the Environmental Protection Officer confirms that standard planning conditions and a Construction Environment Management Plan (CEMP) can adequately control risks to human health, air quality and noise. Flood risk is limited: most of the land is in Flood Zone 1 with a small area in Zone 3, and both the Lead Local Flood Authority and Environment Agency raise no objections provided a drainage strategy and flood-risk assessment accompany any application.

Ecological receptors—including the River Don, nearby coastal European sites and several local wildlife sites—could be affected by water pollution, lighting and accidental spills, but impacts can be avoided or mitigated through design, species surveys and operational safeguards. Landscape and visual change is negligible because new structures will sit below the height of current buildings and are screened by perimeter vegetation. Archaeological potential near the early-medieval St Paul's Monastery will be addressed through desk study and, if needed, field evaluation during the planning process. Day-to-day traffic from the facility will be minimal and less than the historic industrial use, though a CEMP is required to manage construction traffic.

Cumulatively, the project is not functionally linked to major housing or commercial schemes elsewhere in the borough and is unlikely to create additive effects. It also offers modest socio-economic benefits by supporting renewable energy storage and jobs during construction and operation. Overall, the Council concludes that the development's impacts are localised, readily mitigated through normal planning controls and do not warrant a full Environmental Statement; consequently, an Environmental Impact Assessment is not required.
