11. Explanation For Proposed Demolition Work

Why is it necessary to demolish all or part of the building(s) and or structure(s)?

Existing conservatory has reached its lifespan and requires regular maintenance to prevent water ingress. The area of glazing and the polycarbonate roof results in a cold room that does not serve any purpose.
