Description

We are applying for a change of use from C3 (Private Dwelling Home) to C2 (Residential Institution).

We propose to develop the 4 bedroom dwelling house at St Michaels Vicarage to a Residential Children's Home for a maximum of five children and young people.

The house will have adequate parking spaces for up to eight car spaces with more if necessary, three bike spaces and it will also benefit from a unobstructed driveway for emergency service vehicles if required.

The renovation work will adhere to current fire safety legislation and regulations with an A1 fire safety system and the appropriate risk assessments in place prior to commissioning by Ofsted. We always ask the Fire Service to visit the house prior to internal renovation works and advise of any additions to the F60 fire doors, smoke / heat alarms and the fire control panel - none of these works are external. Formal fire risk assessments are carried out on an annual basis.

On the ground floor the garage and office will be combined and made into a Studio Flat which will be used as supported accommodation for a young adult. The existing garage door will be removed and two windows will be fitted in it's place with the remainder of the opening infilled with stone to match the existing.

On the first floor an En Suite will be formed for Bedroom 1. The 2 Stores will be changed into En Suites and a section of wall will be removed to make Bedroom 4 larger with a new stud wall erected to form it's En Suite.

Externally the building will be repaired as required. Windows repainted, walls repointed and roof made good where required.
