Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

30 Underhill Road has undergone extensive building work including a newly laid driveway and the installation of two EV charging ports. Following a site visit I was shown three trees marked as G1 on the sketch plan. The branches of these trees overhang the driveway with pigeons roosting on the lower branches, the droppings of the pigeons have caused significant stains to the new driveway and also covering the EV charging ports. No nests were evident. The trees G1, T1 & T2 are beech trees and are part of a line of trees on the front boundary adjacent to the road.

Work specification:

G1 - 3 metre crown lift to remove the branches overhanging the driveway

T1 & T2 - both trees are diseased and dying, they have significant crown die back, deadwood and little to no foliage. The trees have cracked bark, T2 has what looks like white powder dots on its bark, suggesting beech bark disease, T1 also has evidence of bleeding canker with dark sticky fluid on the main stem - both trees to be felled.

T3 Hornbeam - 3 metre crown uplift to remove branches overhanging EV charging point

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
