Description of Proposed Works

Please describe the proposed works

As advised by the pre-planning application team, I propose to install plain black galvanised railings with square vertical infills to a height of 1 metre. The railing system will consist of approximately 8 posts, with each railing panel measuring approximately 2300mm in length. The railings will be galvanised and powder-coated black for durability and appearance.

I have attached a photograph showing the proposed route of the railings, marked with a blue line and labelled (B). The railings would extend from the existing rear garden post up to the front lamppost. The unit on Palmerston Street is identified as FR43, situated at coordinates [E: 4361633.33], [N: 565500.61]. The railings would be positioned centrally between the grassed area and through the existing rockery at the front of the properties.

There will be approximately 7–8 posts, with one post installed at each railing panel junction. Each railing panel will measure approximately 2300mm in length. The posts will be securely cemented into the ground, and the estimated post locations have been marked on the attached photograph.

I have also attached photographs of the proposed railing design, which is similar to the style previously advised as acceptable by the pre-application team.
