The proposal comprises the change of use of the existing building from a mixed Class B1 (Business) and Class B8 (Storage and Distribution) use to Class E(g)(i) (Office) for use as an accountancy practice.

The existing first floor office accommodation will be retained with no changes. Part of the ground floor, currently used for commercial storage, will be reconfigured to provide a reception area, meeting room, boardroom and ancillary office space to support the accountancy practice.

The proposal also includes minor external alterations comprising the installation of a new pedestrian entrance door behind the existing roller shutter to provide a dedicated client entrance. No extension to the building or increase in floorspace is proposed
