30 Underhill Road has undergone extensive building work including a newly laid driveway and the installation of two EV charging ports. Following a site visit I was shown four trees marked as T1 Beech, T2 Beech, T3 Elm and T4 Beech on the sketch plan. The branches of these trees overhang the driveway with pigeons roosting on the lower branches, the droppings of the pigeons have caused significant stains to the new driveway and also covering the EV charging ports. No nests were evident. The trees are part of a line of trees on the front boundary adjacent to the road. Work specification: T1, T2, T3, T4 - 3 metre crown lift to remove the branches overhanging the driveway. T7 Hornbeam - 3 metre crown uplift and pruning any branches overhanging EV charging point and neighbouring property to prevent possible damage from tree debris and bird droppings.
T5 & T6 - no work required.
All work will be in accordance with BS3998 tree works recommendations.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
